#### **Better Connections Grant**

S. Lotspeich was in attendance to brief the board of a grant opportunity from the VT Agency of Transportation Commerce and Community Development. The Town match is \$9,000. If Waterbury is awarded the grant the Center at the green (Guptil Rd/Maple Street/Hollow Rd/Howard Ave) would become available for public transportation funding. S. #### Greetings,

Here is some information on the proposed Better Connections grant application that we will be discussing on Monday evening. The grant application is due on February 17<sup>th</sup> so this is a preliminary discussion to see if you support having staff prepare a complete application and budget for your consideration at your subsequent meeting on February 13<sup>th</sup>.

The grant program is sponsored jointly by VTrans and the state Dept. of Housing and Community Development. It focuses on downtowns and villages and we are proposing a focus on Waterbury Center village. We have submitted a "Pre-flight Application" to the state and have a remote interview with state program staff on Monday to discuss the project and get their input. I've attached the narrative from that Pre-flight Application that describes the project. In general, the project would be to develop a master plan / study for Waterbury Center village that will address how to connect the two parts of the village, and look at pedestrian access, safety, and traffic calming, especially in the area of the village on Route 100. We would also look at possible wayfinding and interpretive signage as a way to orient and educate visitors and residents, and additional stormwater management to address runoff from roads and the adjacent development to improve water quality.

One of the benefits, if we get the grant and carry out the master plan /study, is that we could apply in the future for a Downtown Transportation Fund grant for Waterbury Center village for further infrastructure improvements.

# **Better Connections Grant Application - Pre-flight Narrative**

Title: Waterbury Center Village Connectivity, Accessibility, and Place Making Study

7. Please provide a short description of your project:

The focus of this project is to improve the connections within and between the two parts of Waterbury Center village in the vicinity of the triangle green near the Grange Hall (the Designated Village area) and along Route 100 in the vicinity of Cold Hollow Cider Mill. The main components of the project will include improving pedestrian access and safety, calming vehicular traffic, strengthening a sense of place within the village, and addressing stormwater runoff from the roadways and adjacent development in the village to improve water quality. Accessibility in and around the village is an important aspect of this project to make sure that all of the village's public spaces are accessible, safe and enjoyable for all people.

8. Please provide a list of project partners and stakeholders:

The current list of stakeholders includes: Revitalizing Waterbury, Inc., the Grange Hall Cultural Center, the Makersphere arts organization, the Children's Literacy Foundation, A River Runs Through It Garden Club, the Town of Waterbury including the Fire Department, and the area businesses including the Cold Hollow Cider Mill.

9. Please share if this project is building off past planning or community engagement efforts:

We are currently in the midst of a Parks Study that includes Hope Davey Park in Waterbury Center village. There has been a robust public participation process as part of that project, including the residents of the village, that is continuing into 2023. The Town recently carried out a public survey on the allocation of ARPA funds and the responses included comments that there is a need for developing pedestrian facilities in Waterbury Center village. VTrans has also done a series of Route 100 Corridor Studies over the past three or more decades and the most recent study identified the creation of pedestrian facilities and traffic calming in Waterbury Center village as priority projects.

10. Please share the project's goals and expected outcomes:

The goal of this project is to create a vision and implementation plan for Waterbury Center village that will develop ways to connect the two parts of the village as one shared place that is accessible and welcoming for all people. Expected outcomes are to develop a plan for pedestrian access and safety throughout the village with possible sidewalks, crosswalks, and paths. Additional outcomes are a concept plan for a wayfinding and interpretive signage system, and additional stormwater treatment including the use of green stormwater infrastructure.

# WARNING FOR THE ANNUAL MEETING OF THE TOWN OF WATERBURY TO BE HELD MARCH 7th, 2023

The inhabitants of the Town of Waterbury who are legal voters in Town Meetings are hereby notified and warned to conduct business to meet in the Brookside Primary School Gym at 47 Stowe Street at 9:00 o'clock in the forenoon on March 7<sup>th</sup>, 2023 to act on the following matters:

**Article 1:** To elect a Moderator to preside at the meetings of the Town whose term of office shall be for the ensuing year.

**Article 2:** To elect by Australian ballot the following offices: Clerk for 1-year; Treasurer for 1-year; one Select Board member for 3-year term and two Select Board members for 1-year terms each; Lister for a 3-year term; Library Commissioner for a 5-year term; and Cemetery Commissioner for a 5-year term.

**Article 3:** To elect by Australian ballot for the Harwood Unified Union School District a School Director for a 3-year term.

**Article 4:** To elect by Australian ballot for the Harwood Unified Union School District a School Director for an unexpired 1-year term.

Note: The polls for voting by Australian ballot on Articles 2, 3 and 4 will be open from seven o'clock in the forenoon to seven o'clock in the afternoon at Brookside Primary School at 47 Stowe Street.

Article 5: Shall the Town of Waterbury change the term of the Town Clerk from a 1-year term to a 3-year term, effective March 5, 2024.

Article 6: Shall the Town of Waterbury change the term of the Town Treasurer from a 1-year term to a 3-year term, effective March 5, 2024.

**Article 7:** To act upon the reports of the several Town Officers with the exception of claims for fees or compensation during 2022.

Article 8: To act with respect to claims of Town Officers for their services during 2022.

**Article 9:** To see what action the Town will take with reference to fixing the date of the tax warrant and to set a date or dates when taxes on such property shall become due and payable and to specify the time of acceptable, the method of delivery, and to see whether the same shall be paid with or without discount and to provide for interest and penalty on such taxes as are not paid when due?

**Article 10:** To vote sums of money for necessary general government, highway, and library expenses, with the same to be expressed either in specific dollar amounts or as a rate or tax on the grand list.

**Article 11:** To see if the voters will authorize a sum of money to be expended from the capital funds for capital projects.

Article 12: To see if the Town will, during 2023, appropriate:

- \$1,375 for support of Circle

- \$1,000 for support of the People's Health and Wellness Clinic
