Chairperson Flanders called the meeting to order at 4:34 p.m.

C. Parks requested time on the agenda to get an update on the Waterbury Commons Development. This will be added to end of the agenda. Agenda approved by consensus.

Public: no comments

<u>Hunger Mountain Forestry:</u> T. Sweet provided an overview of the entire parcel of EFUD land known as the water works. He expects the timber inventory to be completed in mid-March. T. Sweet advised the Commissioners there needs to be consideration made for some control of the mountain bike use on the property. This is considered public land with no current ordinance to prevent public use of the land.

Ice Center UDAG Loan: W. Shepeluk updated the Commissioners on the current status of the UDAG loan the Ice Center and EFUD have now. The balance of that loan is \$338,364.00 with a monthly payment of \$1,804.63, an amortization schedule ending November 2037 and a 2% interest rate. This interest rate is scheduled for review in November 2019. The Ice Center is requesting consideration for an additional \$200,000.00 which will be paid to Community National Bank in order to lessen the burden of debt they current have at a 6.25% interest rate. The Ice Center calculates this refinancing would save them approximately \$8,000.00 per year. W. Shepeluk advised the Commissioners they have \$475,000.00 available for Ioan. By consensus the Commissioners are willing to consider an additional \$200,000.00 loan to the Ice Center at a rate of 2% until November 2024 at which time the interest will need to be reviewed. W. Shepeluk will prepare documents for the Commissioners consideration for the March meeting.

<u>Parsons Solar Project</u>: C. Parsons requested consideration from the Commissioners to allow him to install a solar array on the canopy of the Waste Water Treatment Plant drying bed for a lease fee of 6% annual revenue (estimated to be \$2,700 per year) for a term of 25 years. W. Shepeluk and C. Parsons need to investigate the permit process more before the Commissioners can reach a decision.

Oakwood Estates Request: Lynn Gorski, President of the Home Owners Association of Oakwood Estates previously met with P. Flanders and W. Shepeluk to discuss the possibility of EFUD taking over ownership of the water lines and infrastructure of the development including the homes on Ashford Lane. The system was built in the late 1980's with the condition EFUD not own it due to the necessary pumps. A discussion followed - W. Shepeluk, B. Woodruff and A. Tuscany will work to gather data to assist in determining future maintenance costs of the system for the Commissioners consideration.

Final update on Hubacz court case: December 20th, 2018 the judge ruled she applied the law as determined in the decision of the Supreme Court. The right to appeal period has ended. Total legal expenses for this case \$453,280.00; a portion of this expense was paid by EFUD (former Village of Waterbury) in the amount of \$117,700.00.

Rusty Parker Park Liquor request: The Waterbury Rotary is seeking permission to host a beer tent in the Rusty Parker Park on June 29, 2019 as part of the NQID celebration. N. Sherman made a motion to approve the Rotary Club to utilize the Rusty Parker Park for NQID event on June 29, 2019 and authorize to serve alcohol with a permit. L. Sayah seconded the motion; a vote was held and passed unanimously.

Update on removal and deconstruction of building located at 51 South Main: B. Woodruff updated the commissioners, progress continues and soon the exterior of the building will begin to be dismantled. The contractor will keep the parking lot open as long as possible. The use of a lift will cause it to be fenced off.

Monthly Reports: B. Woodruff has mailed a letter to the individuals associated with the inline hydro project to urge the project forward.

Waterbury Commons Development: B. Woodruff has contacted ECI for an estimated cost of replacement of the deepest section of the sewer line, from Manhole 1 to 2. With the use of pipe bursting technology this is estimated to cost \$100,000.00. W. Shepeluk will have a draft letter for the Commissioners consideration at the next meeting.

W. Shepeluk and B. Woodruff spoke to the Commissioners regarding a parcel of land, presumed to be owned by EFUD on Armory Drive that the State of Vermont would like to use for soil disposal during the Main Street Reconstruction project. Consensus was to determine ownership and process for selling the parcel to the State of Vermont. B. Woodruff to follow up at March meeting.

Minutes: B. Finucane made a motion to approve the minutes of January 9, 2019 as written. L. Sayah seconded the motion; a vote was held and passed unanimously.



#### Summary

Early in the month of January, we were notified of a sprinkler line leaking on Elm Street. Unfortunately, the valve box had been paved over and damaged during the recent work on Elm Street. We cut through the pavement to the box, replaced what turned out to be a damaged top section, and were able to gain access to the sprinkler line valve to shut it down. In the end, the sprinkler line was shut down for the owner to schedule repair, and we ended up with a working valve box. We may revisit this valve box and repair the top section in a more permanent fashion.

We dealt with a shutoff on O'Hear court as well. The residence was vacant and had a very high water usage since last quarter. When we arrived to shut the water off at the owner's request, we noticed a window open, which may have contributed to a pipe freeze. It was not easy finding the curbstop, as it was so close to the foundation that we were unable to get a good metal detector signal on it. In the end, access to good plans with ties to the curbstop saved us, as we were able to quickly measure and locate the curbstop.

We experienced an issue with the typically bulletproof CL17 chlorine meters this month as well. The post-filter CL2 reading became erratic, with results spiking up and down, often to the point where it triggered alarms and shut the plant down. To address this issue, we utilized the Sweet Wells while the CL17 was unreliable. We attempted several fixes and troubleshooting protocols, but were unable to fix it. We scheduled a Hach technician to come out and perform service. He determined that the issue was with the colorimeter unit itself, which is not a piece we could have easily replaced. The CL17 is now operating very well and we are back on surface water treatment.

January marked meter reading time. With Matt back full time, and Brad still assisting as needed, meters were read efficiently, despite conditions which were much less cooperative some days than others. The short January thaw during the last week of the month was a welcome sight.

With fewer outdoor projects this time of year, it has also been a good time to catch up on housekeeping and some organization around the plant.

Well 1 was not used during the month of January. The Sweet Well was on in January for 13 days at ~189 GPM for a total flow of 3,545,800 Gallons.
