CENTRAL VERMONT REGIONAL PLANNING COMMISSION (CVRPC) PRESENTATION

Topic: Winooski River Tactical Basin Plan

A full presentation on this will be held 10/9/18 at the CVRPC monthly meeting.

- The plan is on a 5-year update cycle for testing, assessment, remediation and protection, outreach and implementation.
- There are 15 watersheds/basins in the State that are part of this study and planning process.
- Tactical planning involves monitoring and addressing the phosphorus that flows into Lake Champlain from the Winooski River basin.
- Monitoring sites are managed by multiple organizations.
- Top objectives and strategies
 - · Protect river corridors and floodplains
 - Increase knowledge of water quality conditions
 - Implement agricultural Best Management Practices (BMPs)
 - · Resolve E. coli bacteria impairments
 - Manage stormwater from developed areas

- · Improve littoral or riverine zone habitat
- Inventory and prioritize municipal road erosion issues and sites
- Provide technical and financial assistance for upgrades to wastewater treatment facilities
- Prioritize wetland and floodplain restoration projects
- · Prioritize remediation of erosion on forest logging roads and log landings
- Assist municipalities in identifying areas of landslide hazards
- High quality waters were identified and were related to the associated land use and the water quality related to the runoff for those use areas.

OTHER BUSINESS

- 1. A stormwater master plan is being considered for Waterbury and the Floodplain Management Working Group is having a presentation by CVRPC at their 9/25 meeting. CVRPC has offered to apply for state funding to carry out this master plan.
- 2. Steve presented an outline for a presentation at the Select Board public hearing on 10/15/18 on Draft #2 of the Municipal Plan update. Martha and Ken commented and provided requested changes for the outline.
